NACBA MEMBERSHIP CLASSIFICATIONS

Active (voting) membership may be granted to those who are employed full-time or part-time on the staff of a Christian church in a business administration or administrative capacity. This may include denominational members with like responsibilities who serve at other levels of their denominations such as Presbyteries, Synods, Conferences, Dioceses, et cetera; and active duty members of the United States Armed Forces who are assigned duties as Chapel Manager, Chaplain's Assistant, or other Christian business administrative duties in their military service.

Associate (voting) membership may be granted to those engaged in an activity closely related to Christian business administration in a Christian institution or not-for-profit organization.

Business (non-voting) membership may be granted to individuals or individuals who represent organizations wishing to join NACBA for commercial purposes and who desire to join in the support of NACBA, its purposes, and its programs. This category includes those individuals or individuals representing organizations that provide consulting services to churches.

Student (non-voting) membership may be granted to individuals who are full-time students in a college or seminary and are not actively engaged in any way in Christian business administration as a vocation, but who are interested in church business administration. Student membership is limited to not more than a five-year period.

Affiliate (non-voting) membership is for individuals who do not meet the definitions for Active, Associate, or Business membership.
